SPEAKING BEFORE THE COLUMBUS DEVELOPMENT COMMISSION:

THE CHAIR OF THE DEVELOPMENT COMMISSION WILL PRESIDE OVER THE MEETING AND RECONGNIZE PERSONS WHO ARE ENTITLED TO SPEAK. DO NOT COMMENT ON AN AGENDA ITEM UNLESS YOU ARE RECONGNIZED BY THE CHAIRPERSON. PLEASE SPEAK INTO THE MICROPHONE WHILE ADDRESSING THE COMMISSION.

GENERALLY, EACH CASE WILL FOLLOW THIS PROCEDURE:

1. CHAIR OF THE DEVELOPMENT COMMISSION WILL INTRODUCE EACH CASE;
2. STAFF WILL PRESENT AN OVERVIEW OF THE APPLICATION AND CITY DEPARTMENTS RECOMMENDATION;
3. CHAIR OF THE COMMISSION WILL ASK IF ANY MEMBER OF THE AUDIENCE WISHES TO COMMENT ON THE CASE (THIS IS TO GET A HEAD COUNT OF THOSE WISHING TO SPEAK);
4. APPLICANT WILL ADDRESS THE COMMISSION AND ANSWER ANY QUESTIONS;
5. THE GENERAL PUBLIC MAY ADDRESS THE COMMISSION IN THE FOLLOWING ORDER:
 - a. A REPRESENTATIVE OF THE APPROPRIATE AREA COMMISSION WITHIN WHOSE JURISDICTION THE SUBJECT PROPERTY IS LOCATED;
 - b. REPRESENTATIVES OF NON-PROFIT CIVIC ORGANIZATIONS WITHIN WHOSE JURISDICTION THE SUBJECT PROPERTY IS LOCATED;
 - c. PROPERTY OWNERS ADJACENT TO THE SUBJECT PROPERTY;
 - d. OTHER CONCERNED CITIZENS.
6. DEVELOPMENT COMMISSION WILL THEN VOTE ON THE PROPOSAL, GIVING ITS RECOMMENDATION TO CITY COUNCIL.

NOTE: THE CHAIR OF THE DEVELOPMENT COMMISSION LIMITS THE NUMBER OF PERSONS WHO MAY SPEAK REGARDING ANY AGENDA ITEM TO NOT FEWER THAN THREE PERSONS FOR AND THREE PERSONS AGAINST SUCH ITEM AND LIMIT THE AMOUNT OF TIME EACH MAY SPEAK TO THREE MINIUTES PER PERSON OR, IN ALTERNATIVE, MAY LIMIT THE TOTAL AMOUNT OF TIME FOR SUPPORT OF AN AGENDA ITEM TO NINE MINUTES AND TOTAL AMOUNT OF TIME FOR OPPOSITION TO AN AGENDA ITEM TO NINE MINUTES. THE SPOKESPERSON FOR THE AREA COMMISSION, NEIGHBORHOOD ASSOCIATION OR CIVIC GROUP, IF ANY, WHICH REPRESENTS THE SUBJECT AREA WILL HAVE FIRST OPPORTUNITY TO SPEAK FOLLOWING APPLICANT'S PRESENTATION. SUBSEQUENT SPEAKERS MAY INDICATE CONCURRENCE WITH OR OPPOSITION TO PREVIOUS STATEMENTS AND BRING UP NEW, NON-REPETITIVE MATTER.
