The roll call of Board Members showed fifteenth (15) members present.

Each representative introduced themselves.

### NEW BUSINESS

- Identified possible locations for reserved food carts in the Short North Area:

#### **West side of High Street:**

677 N. High Street- in front of Chase Bank- NOT ON THE BRICK SIDEWALK AREA

747 N. High Street- near Insomnia Cookies

815 N. High Street- in front of the Greystone towards the north end of the building and away from street sculpture\*

847 N. High Street- in front of the Dakota which houses the Alibi Bar

885 N. High Street- Roths- currently vacant- could be used until tenant is determined\*

965 N. High Street- Vamp boutique- closed during MFV hours

983 N. High Street- Treaty Bear\*

1031 N. High Street- Front of Equitas north of the driveway\*

1055 N. High Street- would need to slightly move bus stop bench (north of Chophouse)

1057 N. High Street- See 1055 N. High Street

1145 N. High Street- 2 possible reservation spaces just north of Magnolia Thunderpussy

#### **East Side of High Street:**

654 N. High Street- sidewalk may be too narrow

698 N. High Street- currently under construction requiring pedestrians to walk in the street (consider for future use)

830 N. High Street- in front of the former Melt- which is vacant\*- may be temporary depending what moves in the space

886 N. High Street- by Verizon- there may be 2 potential spots- one on either side of bus benches

870 N. High Street- close to Arch City Bar which has open front in warm weather, UDF and there is a crosswalk

974 N. High Street- front of boarded up entryway

1006 N. High Street- Great Clips and Anthem

1020 N. High Street- close to Julep and there is a crosswalk that makes it unusable

1066 N. High Street- front of 3rd Avenue Community Church\*

1144 N. High Street- front of Michael's Goody Boy- liquor establishment moving in (?) and close to intersection/crosswalk

\*Denotes preferred locations

- Board was advised that of the 38 PROW Permits issued 23 are pushcarts.
- Next VFH Board meeting scheduled for 04/27/2023 to discussion for next board meeting: MFV Rules and Regulations and possible RFP for reservation places.
