# APPLICATION FOR ESTABLISHMENT OF A DESIGNATED OUTDOOR REFRESHMENT AREA

## I. INTRODUCTION AND SUBMITTAL OF APPLICATION

Pursuant to Ohio Revised Code (“ORC”) Section 4301.82, I, Andrew J. Ginther, Mayor of the City of Columbus (“the City”), respectfully submit this application to Columbus City Council for approval and enactment of the Center City Designated Outdoor Refreshment Area (DORA) in the area depicted and described below, encompassing the western part of Downtown and the eastern part of the Franklinton neighborhood.

The Center City DORA will be operated by Center City DORA, Ltd. (“the DORA LLC”), a subsidiary of the Columbus Downtown Development Corporation (“CDDC”), in cooperation with the Capital Crossroads Special Improvement District and the Franklinton Special Improvement District.

## II. POPULATION REQUIREMENTS

Effective March 23, 2022, ORC 4301.82(D) authorizes municipalities with a population of more than fifty thousand to establish up to six outdoor refreshment areas. Currently, there exists only one DORA in the City of Columbus in the neighborhood known as the Arena District.

The United States Census Bureau estimates that the population of the City of Columbus is 907,971 as of July 1, 2022.<sup>1</sup>

### III. BOUNDARY MAP OF THE PROPOSED DORA

The boundaries of the proposed DORA are depicted in the map provided in **Exhibit A**. The DORA boundary encompasses 0.62 square miles (396 contiguous acres) in size, which is less than the maximum of one (1) square mile (640 contiguous acres), in accordance with ORC 4301.82(B)(1)(a).

A list of all parcels and street addresses that define the DORA boundary are listed below in **Exhibit B**. However, a general overview of the proposed Center City DORA boundaries are as follows:

- Western boundary: Gift Street
- Eastern boundary: 4<sup>th</sup> Street (with the addition of Cherry Street between 4<sup>th</sup> Street and Zettler Street)
- Northern boundary: Broad Street on the western half and Nationwide Boulevard on the eastern-most part
- Southern boundary: Main Street and extending to Mound Street in the eastern-most area

Active areas of the DORA within the boundary are defined as all parts of the pedestrian public right-of-way, including, but not limited to, sidewalks, crosswalks, and public spaces, such as parks, plazas, and greenways.

Qualified permit-holding businesses whose exterior faces the right-of-way within or along the boundary are eligible to participate in the DORA.

### IV. NATURE AND TYPES OF ESTABLISHMENTS

In accordance with ORC 4301.82(B)(2), the nature and types of establishments that will be located within or adjacent to the proposed DORA include a broad array of institutions, businesses and uses, including retail, office, residential, dining and drinking establishments, entertainment venues, and services sectors.

There is no intention of changing the nature and types of establishments in the DORA. Rather, the DORA is intended to support these establishments by serving as an amenity to residents and employees and attracting more visitors and customers to them.

Downtown represents a dense, diverse built environment with a variety of uses and purposes. Within the Center City DORA, many of the buildings contain businesses with retail, restaurants, and commercial services on their first floor, with upper levels consisting of office space and residential units. There are also institutional uses typical of a downtown within the proposed DORA boundary, such as the Ohio Statehouse, the Supreme Court of Ohio, Columbus City Hall, James A. Rhodes State Office Tower, the Vern Riffe Center for Government and the Arts, and city-owned park land.

Residential housing within the proposed DORA consists primarily of urban apartments and condominiums (usually located on the second floor or higher of buildings) along with a small number of townhomes at LC RiverSouth, near Front and Town Streets, and at the corner of 4<sup>th</sup> and Gay Streets.

## **V. QUALIFIED PERMIT HOLDERS**

In accordance with ORC 4301.82(B)(3), the Center City DORA will encompass a minimum of four qualified permit holders as defined by ORC 4301.82(D)(1). The qualification of the permit holders is defined by ORC 4301.82(A)(1) as an A-1, A-1-A, A-1c, A-2, A-2f, or D class permit (not including D-6 or D-8 permits) issued under Chapter 4303.

To date, at least 80 current qualified permit holders have been identified in the proposed DORA and are listed in **Exhibit C**.

## **VI. LAND USE AND ZONING**

In accordance with ORC 4301.82(B)(4) and as depicted in **Exhibit D**, the uses of land within the proposed DORA boundary are zoned DD – Downtown District and EFD – East Franklinton District.

Attached as **Exhibit E** is a letter from the City’s Department of Building and Zoning Services confirming that the uses of land within the DORA are permitted and in accordance with the Columbus Downtown Design Guidelines, Franklinton Review Board Guidelines, and Columbus Zoning Code.

## **VII. SAFETY PLAN**

The City of Columbus and Center City DORA, Ltd. are committed to ensuring the safety of DORA patrons, as well as visitors, residents, and employees in the area.

In accordance with ORC 4301.82(B)(5), the proposed requirements for the purpose of ensuring public safety within the Designated Outdoor Refreshment Area (DORA) are as follows:

### Fire/EMS Responsibilities

The Columbus Division of Fire will be responsible for providing Fire, Rescue, and EMS within the DORA. Columbus Fire Station 1 & 9 is located at the northeast corner of the DORA boundary at 300 N 4th Street. Additionally, Station 2 is located at 150 E. Fulton Street, just outside the southeast border of the DORA boundary.

For planned events that may draw larger than normal attendance in and around the DORA, the Fire Chief may station personnel and/or equipment in a location within or near the DORA to allow for an immediate response.

### Law Enforcement Responsibilities

The Columbus Division of Police will be responsible for providing law enforcement services within the DORA. Precinct 16 on Patrol Zone 5 encompasses Downtown Columbus and Franklinton, and the precinct substation located at 333 W. Town Street is within the proposed DORA boundary.

The current staffing profile of the officers and supervisors assigned to the precinct on any given shift is adequate for effective patrolling of the DORA. Patrol officers are also augmented with additional patrol

units that work varying shifts. There are two (2) bicycle officers from 7:00 a.m. – 3:00 p.m. and four (4) from 3:00 – 11:00 p.m. when the 16<sup>th</sup> precinct is fully staffed.

Also housed in the Precinct 16 substation is the Zone 5 Community Response Team, which is a group of officers responsible for problem-oriented policing projects in the zone, as well as patrolling other public events. This team of officers and a sergeant are bike-certified.

#### Additional Safety and Security Coverage

The proposed Center City DORA has additional safety and security coverage throughout most of the area and operating hours. This coverage is provided by the Capital Crossroads Special Improvement District, Franklinton Special Improvement District, Columbus Downtown Development Corporation, and Capitol South Community Urban Redevelopment Corporation via safety ambassadors (on foot and bike), private security, and special duty officers (Columbus Police officers, requested and paid for by the Capital Crossroads SID, CDDC, and Capitol South).

In accordance with ORC § 4301.82(F)(1)(d), a map of the coverage areas, staffing profile and schedules can be found in **Exhibit F**.

#### Special Events

As has been the case before creation of the DORA, all permitted special events taking place within the DORA boundary will be required to provide a safety plan specific to their event as part of the standard permitting process with the City's Recreation and Parks Department.

The City and the DORA LLC believe the current safety and law enforcement staffing levels, including those already required to be a part of special events, are sufficient to maintain public safety within the DORA. However, the City, DORA LLC and its partners will continually assess the DORA's operation and any issues that arise to adjust the safety plan as needed in the City's reasonable discretion, including, but not limited to the hiring of special duty officers.

The City retains the right to temporarily or indefinitely suspend the operations of the DORA or alter operational parameters at their sole discretion if determined necessary for public health, safety or welfare.

### **VIII. PUBLIC HEALTH AND SANITATION PLAN**

In accordance with ORC § 4301.82(B)(5), (F)(1)(e), and (F)(1)(f), a plan has been developed that will help maintain the appearance and public health of the area within the DORA. Based on feedback from other communities with DORAs of similar size and scope, the Center City DORA is not expected to generate a significant increase in waste and, therefore, the Public Health and Sanitation Plan can be executed with existing resources as outlined below.

There are 254 existing public trash and recycling receptacles within the boundary of the DORA, a map which can be found in **Exhibit G**. These containers are serviced as follows:

- **Public Right-of-Way:** The City's Department of Public Service ("DPS") is responsible for installing and routinely emptying the trash and recycling receptacles on the public right of way downtown.

Stations are serviced either Monday, Wednesday, and Friday or Tuesday and Thursday, based on how full the containers in different areas are.

- Scioto Mile and Dorrian Green: From May 1 to September 30, the Recreation and Parks Department services the city trash receptacles along the Scioto Mile on both the east and west sides of the river, including Dorrian Green, every day during normal business hours (7:00 a.m. - 3:30 p.m.). Two staff members are required for collection and disposal and the task averages 4-6 hours to complete. During the off season (October 1 to April 30) the bins are checked twice per week (typically Monday and Friday during normal business hours). There is no scheduled weekend service during the off season.
- Columbus Commons: The 12 permanent trash and recycling containers are serviced two times per week during the off-season (January through mid-April) through a contracted company as part of a 4-hour shift that also involves picking up litter and cleaning restrooms, and the Commons' internal operations team maintains them between those visits. During the event season (mid-April through December), trash and recycling receptacles are emptied 3 days per week at a minimum, and more often as needed to support the event schedule.
- Franklinton: In anticipation of the DORA, the Franklinton Board of Trade and the City recently installed additional trash and recycling containers at seven key locations on W Rich, W Town, and McDowell streets. The trash units are serviced by the City's Department of Public Service and the Franklinton Special Improvement District, while the Franklinton SID is solely responsible for servicing the recycling containers. The trash receptacles on Broad Street in Franklinton are also serviced regularly by the Department of Public Service.

Center City DORA, Ltd. is committed to working with the City and the Capital Crossroads and Franklinton Special Improvement Districts on an ongoing basis to evaluate areas in need of placement or relocation of a trash or recycling receptacle to best support the proper disposal of DORA containers.

## **IX. SIGNAGE PLAN**

In accordance with ORC 4301.82(F)(1)(b), approximately 88 signs will be displayed throughout and along the boundary of the Center City DORA. The signs are depicted on attached **Exhibit H**. District identifier and informational signage will be placed in key areas of the DORA with greater anticipated use by patrons. Boundary signs will be located at street intersections along the boundary of the DORA. The location and spacing of the signs are shown in attached **Exhibit I**. All planned signage will be installed in coordination with appropriate City departments.

Additionally, information about the DORA will be displayed on three IKE digital kiosks that are located inside the proposed DORA boundary.

The DORA LLC will continually assess the need for additional signage in and around the Center City DORA to ensure the rules and boundaries are displayed clearly to patrons.

Qualified and participating permit holders that may serve DORA beverages will display a sign (in an exterior facing window or door) informing patrons that DORA beverages can be purchased at the establishment. Participating establishments will also be provided with interior signage by the DORA LLC to display the DORA rules. Non-permit-holding retail establishments may display a sign indicating

whether they do or do not accept patron entry with DORA beverages. These signs are depicted in **Exhibit H**.

If a special event organizer requests to participate in the Center City DORA and is approved by the Columbus Recreation and Parks Department, Columbus Division of Police, and the DORA LLC, as applicable, the event organizer will be responsible for placing temporary DORA signage (templates to be provided by Center City DORA, Ltd.) as deemed necessary by the DORA LLC and the City to communicate DORA rules.

## **X. DORA RULES OF OPERATION**

### **A. Hours of Operation**

In accordance with ORC § 4301.82 (F)(1)(c), the hours of operation for the DORA will be:

- 11:00 a.m. to 10:00 p.m., daily

The Mayor, Columbus Division of Police, Columbus Recreation and Parks Departments, and Center City DORA, Ltd. reserve the right to temporarily suspend or reduce the DORA's operating hours to accommodate the permitting of special events that may occur within the boundaries of the DORA or to address safety incidents or other issues or concerns.

### **B. Official DORA Container**

In accordance with ORC § 4301.82 (F)(1)(g), beer, wine, and intoxicating liquor shall only be consumed within the DORA as follows:

- Beer, wine, and intoxicating liquor shall only be served and consumed within the DORA in 20 oz. or less non-glass, eco-friendly containers, including:
  - Plastic cups that can be recycled in the current stream
  - Aluminum cups
  - BPI compostable cups

No other containers will be permitted unless approved by the City's Refuse Administrator.

- The DORA containers shall be distinctly marked with a specifically designated logo or sticker approved by the City (the "Official DORA Sticker") as depicted in **Exhibit J**. No other cups or stickers will be permitted.
- Used containers must be recycled or properly disposed of before exiting the DORA boundary, or when entering any liquor establishment of a qualified permit holder (including special event perimeters) or a business displaying a sign prohibiting DORA beverages.

### **C. Additional Requirements**

In accordance with ORC § 4301.82 (B)(5), and in conjunction with other rules, standards and requirements set forth in this application, additional rules and requirements for the purpose of ensuring public safety and health within the DORA are as follows:



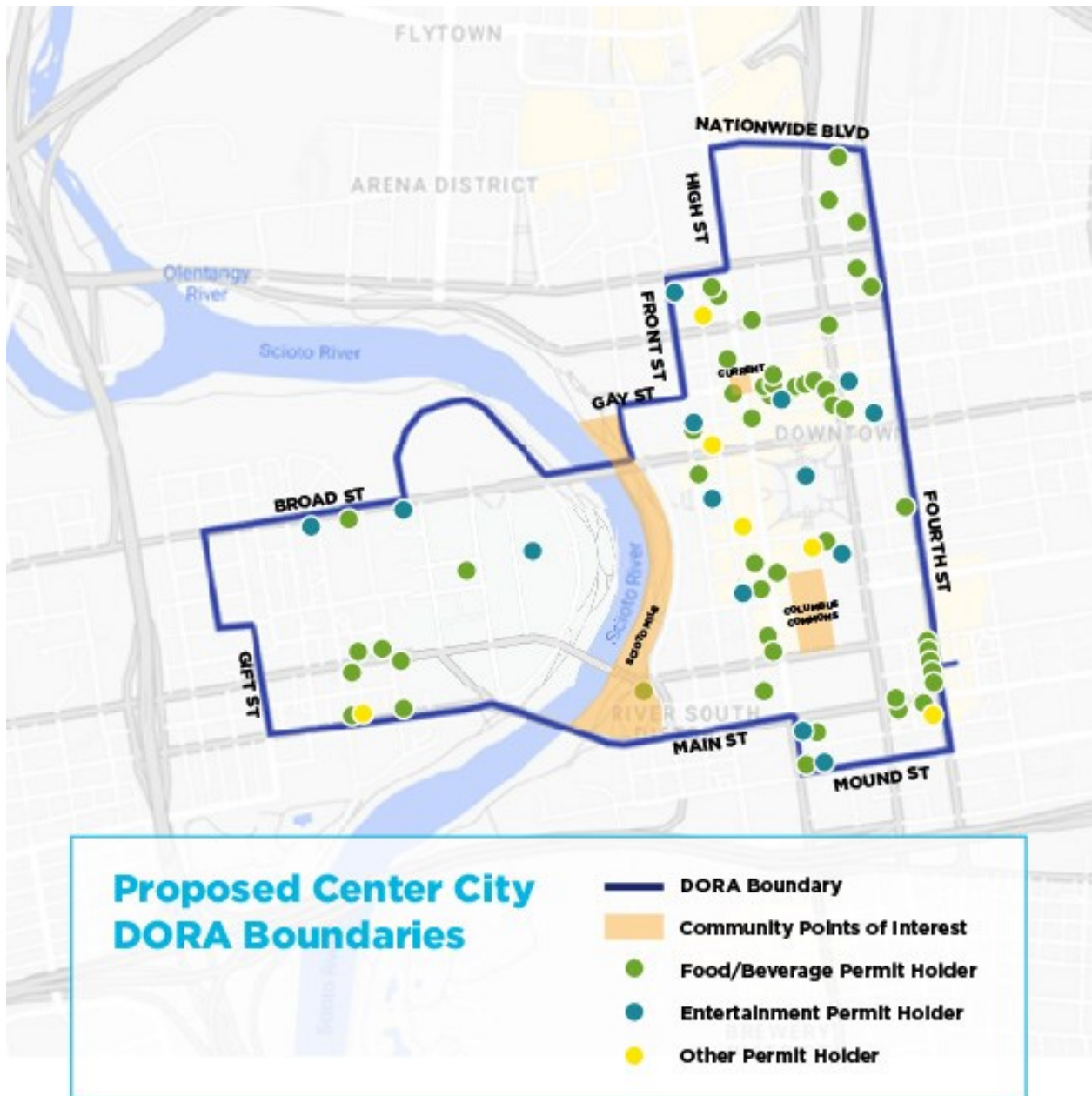
1. A person may have in their possession a single open container of beer, wine, or intoxicating liquor at a public outdoor location within the DORA provided it was purchased from an establishment that is a qualified permit holder with an outdoor refreshment designation as defined in ORC 4301.82(A)(1), is located in the DORA boundary, and has signed an agreement approved by the Center City DORA, Ltd., to participate in the DORA.
2. In accordance with ORC Sections 4301.62 and 4301.82, no person shall do any of the following:
  - a. Enter the premises of an establishment of a qualified permit holder within the DORA while possessing an open container of beer, wine, or intoxicating liquor acquired elsewhere.
  - b. Enter the premises of a non-permit holder establishment that does not allow DORA beverages.
  - c. Possess more than one (1) DORA beverage at a time.
  - d. Leave the boundaries of the Center City DORA with an open container.
  - e. Possess or consume DORA beverages outside of the DORA hours of operation.
  - f. Possess an open container of beer, wine, or intoxicating liquor while being in or on a motor vehicle within the DORA, unless the possession is otherwise authorized under division (D) or (E) of ORC § 4301.62.
3. Owners of unpermitted businesses may determine if and when they allow open DORA containers in their establishments.

## **XI. COMMUNITY SUPPORT, PUBLIC NOTICE, AND LEGISLATIVE APPROVAL PROCESS**

To date, there has been significant community support expressed for the Center City DORA. As part of the public engagement efforts led by the Columbus Downtown Development Corporation in partnership with the Franklinton Board of Trade and Capital Crossroads Special Improvement District, a community input survey was completed. A summary of the results from this survey can be found in **Exhibit K**. Additionally, letters of support from key stakeholders are included in **Exhibit L**.

Following filing of this application with the Clerk of Council and in accordance with ORC 4301.82(C), the Clerk will publish public notice of this application in the *City Bulletin* and *The Daily Reporter*, which is a newspaper of general circulation in the municipal corporation or township as outlined in accordance with Section 7.16 of the ORC. The notice will indicate that the application is on file and available for inspection in the Clerk's office. Additionally, the application will be available for review in the *City Bulletin*. Further, the notice will indicate the date and time of the identified City Council committee hearing to which the authorizing legislation has been referred to provide for a public hearing on the proposal.

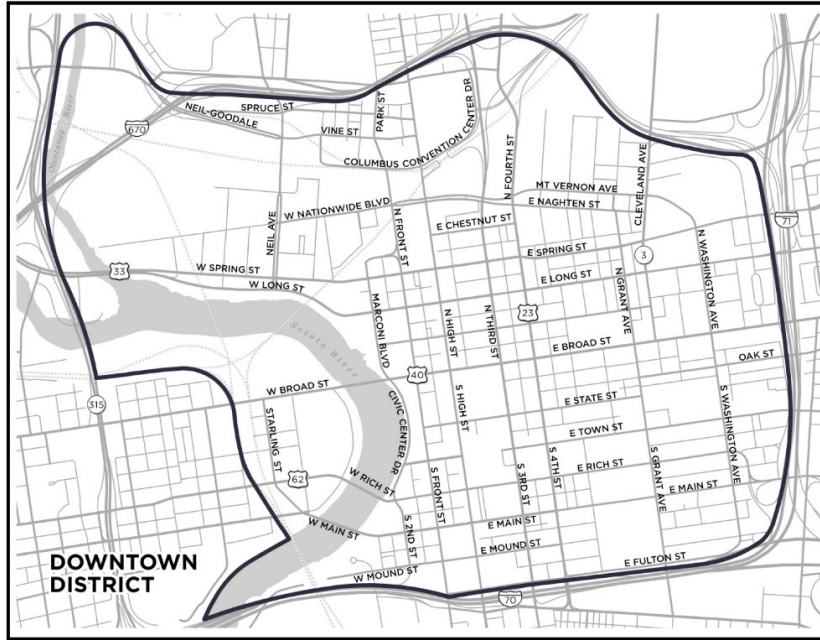

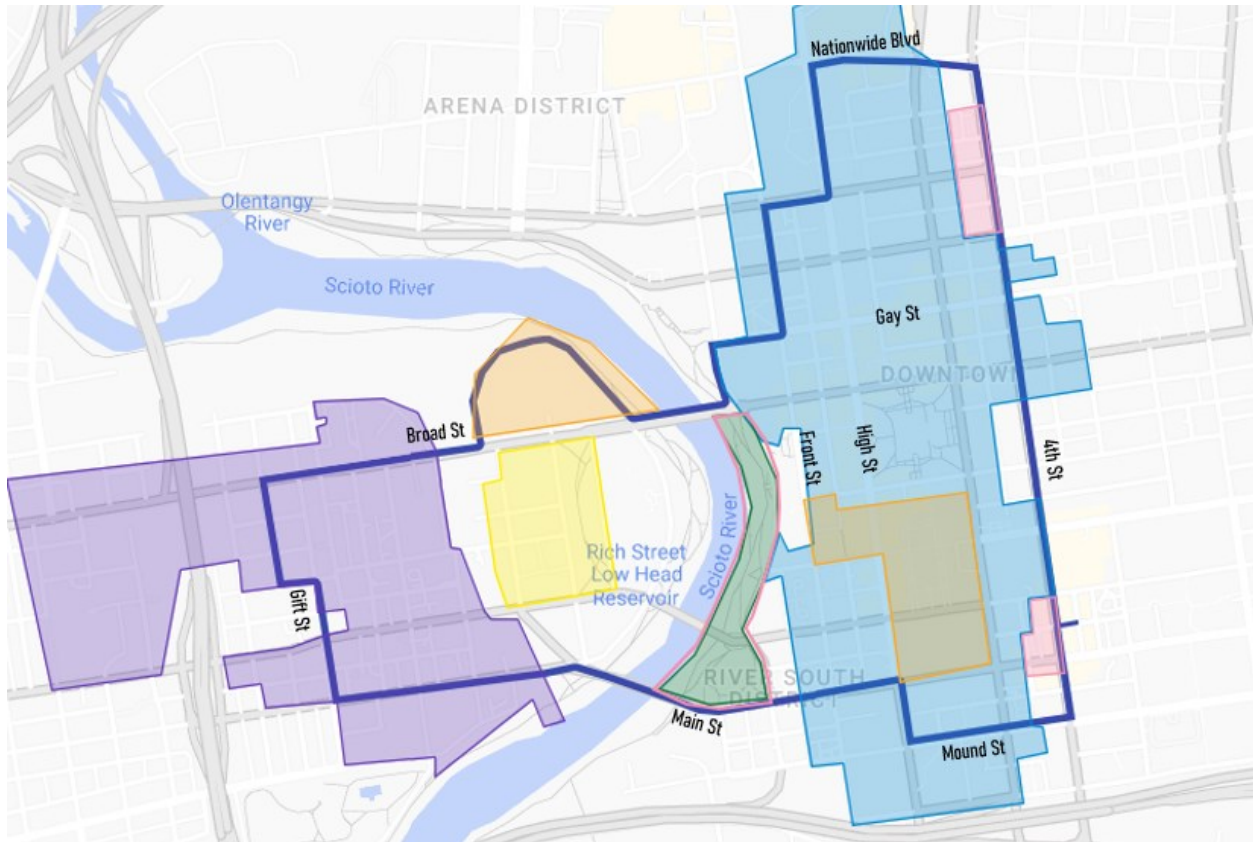

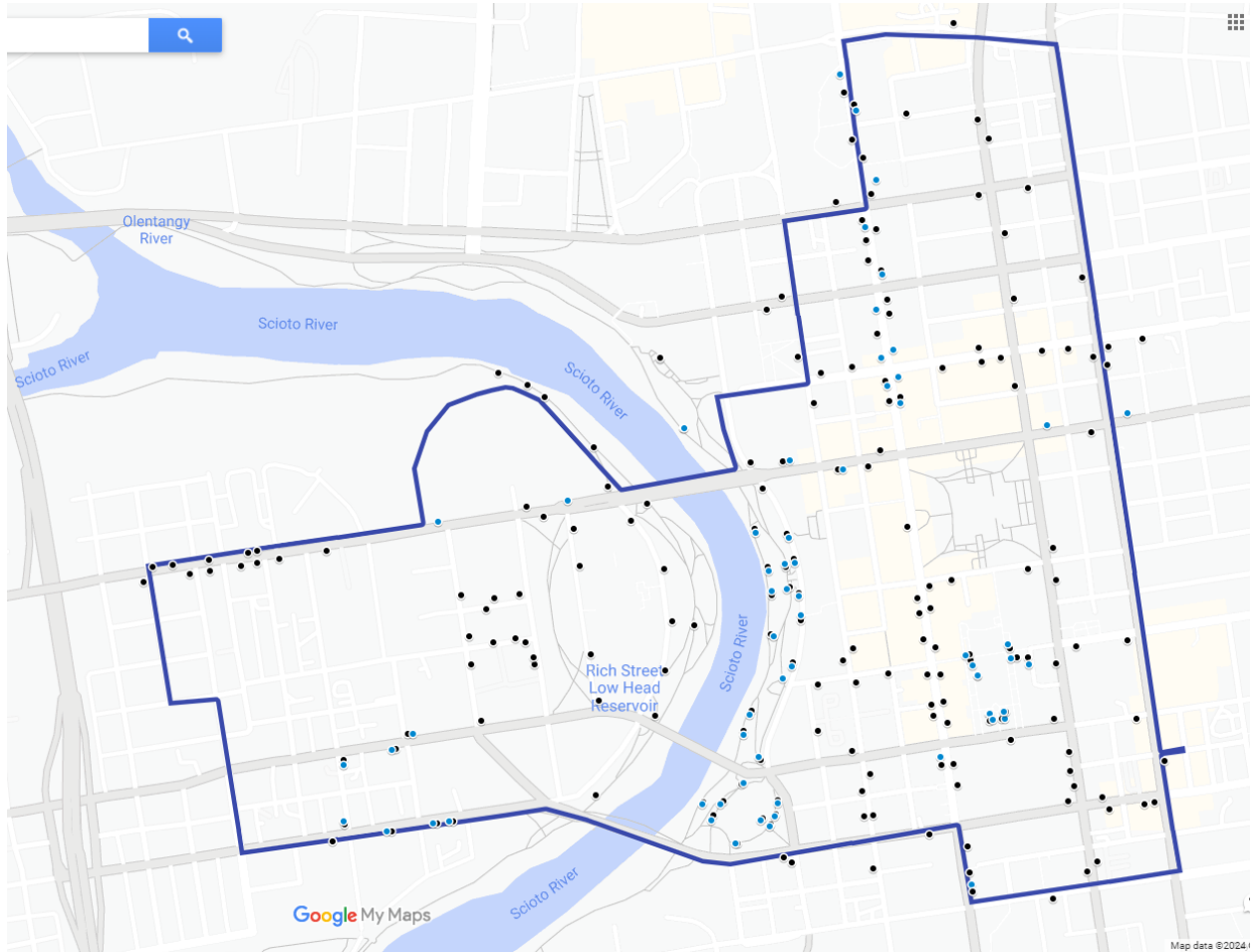

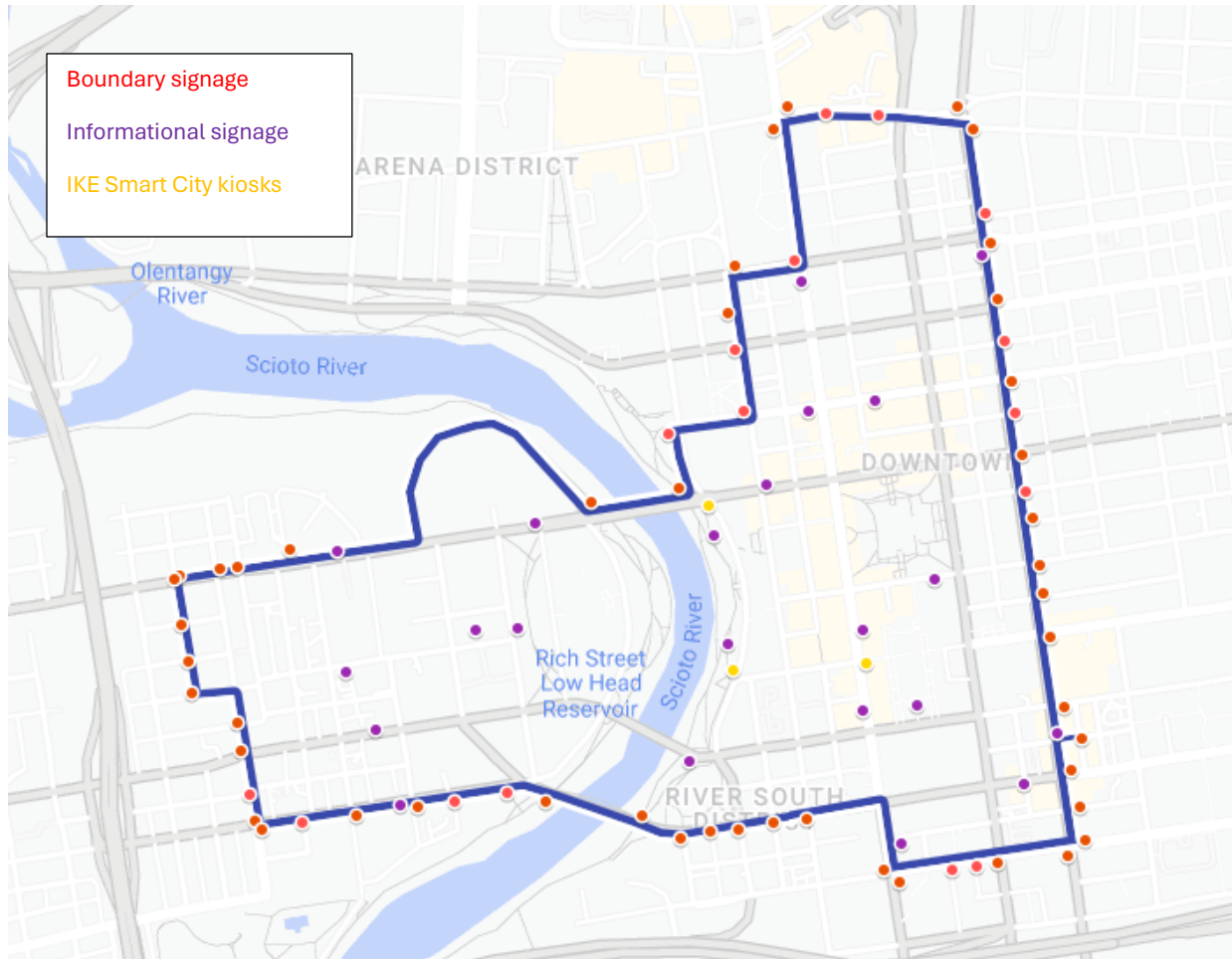

**Boundary Signs:** Each intersection along the DORA boundary will have a minimum of one (1) sign. Where available and approved by the Department of Public Service, an aluminum sign will be affixed to existing City infrastructure in the public right-of-way. If an intersection or key location along the boundary requires signage, but there is no infrastructure available to hang an aluminum sign from, a sidewalk decal will be used. Sidewalk decals will also be used to supplement aluminum boundary signs in areas where extra boundary enforcement is needed.

**Informational Signs:** Aluminum signs displaying the Center City DORA rules will be placed in key areas in the DORA district where greater anticipated DORA patronage is expected. These will be installed on existing City infrastructure in the public right-of-way.

**Additional signage:** Digital graphics displaying information on the DORA will be displayed on the IKE kiosks within the DORA boundary. Additional signage beyond what is included in this plan may be added if deemed needed once the DORA is operational.

**All signage that requires installation within the public right-of-way will go through proper approval and permitting with the Department of Public Service.**

## EXHIBIT K: COMMUNITY INPUT SURVEY RESULTS

### Survey Submissions:

The Center City DORA community survey was active from November 17, 2023 to December 13, 2023. The total number of submissions was 363.

### Results Highlights:

- 82% of respondents believe the proposed DORA would make them more likely to visit or stay longer in the Downtown/Franklinton areas.
- 83% of respondents indicated that they were comfortable with the proposed DORA's boundary and operating hours.
- Those respondents who had experienced DORAs in other communities felt very positively about the proposed DORA and did not indicate any major concerns.
