Subject: 2024 Promotional Police Lieutenant and Police Commander Exams

The following is a summary of the items discussed at the 2024 Police Promotional Lieutenant and Commander Exams C.U.P.A. committee meeting on Monday, June 5, 2023, at 11:00 a.m. which consisted of representatives from the <u>C</u>ivil Service Commission (CSC), <u>U</u>nion—(Fraternal Order of Police, Lodge No. 9 (F.O.P.)), the Division of <u>P</u>olice, and <u>A</u>dministration (Department of Public Safety). Topics of Discussion:

CSC held this CUPA meeting in person and via Webex. Prior to the meeting CSC staff verified the receipt of signed security agreements from CUPA members.

The purpose of the meeting (attachment 1 Agenda) was to discuss the plans for the 2024 promotional exams to Police Lieutenant and Police Commander as provided in the F.O.P. contract. CSC confirmed that the following individuals will serve as representatives during the 2024 Police Lieutenant and Police Commander promotional examination processes:

- Police Deputy Chief Nicholas Konves—City of Columbus Division of Police
- Brian Steel—F.O.P Liaison
- Dr. Joel Wiesen—F.O.P Test Consultant
- Doug Sarff—Department of Public Safety

The CSC exam leads are as follows:

- Police Lieutenant-Richard Cherry, Personnel Analyst II
- Police Commander-Chelsea Whims, Personnel Analyst II
- Overall Exam Contact-Laura Hausman, Personnel Administrative Manager

Job Observations and Interviews:

CSC staff may request to participate in job observations and/or interviews with Police Commanders (approximately 2 hours each) and 8-hour ride-a-longs with Police Lieutenants to gain knowledge and familiarity with these job classes. CSC personnel will coordinate the observations and/or ride-a-longs and Police Deputy Chief Konves will assist as needed.

Exam Plans:

CSC notes that due to the 2022 Police Commander eligible list being exhausted, the timeline for the 2024 exam is scheduled earlier than the previous administration. The 2024 Police Lieutenant exam is planned for a similar timeline as previous Police Lieutenant exams.

Important Dates

The CSC presented the Police Commander tentative dates/exam schedule (attached document 2a). The division liaison voiced concern over the date of the paper inspection due to "mandatory no days off" during the Pride Festival every year. Possible alternative dates were discussed and included selecting an alternative date that will allow the paper inspection to be offered over two different weeks to better accommodate those on vacations. Both the F.O.P and the division had no further suggestions for edits to the Important Dates. The edited date for the paper inspection appears in attachment 2a. This edit changed the first date of the paper inspection from June 14 to June 13, 2024.

The CSC presented the Police Lieutenant tentative dates/exam schedule (*attached document 2b*). There were no objections or concerns noted with this timeline.

The CSC will send emails to potential candidates through the Division Liaison regarding the filing period (opening and closing) and when the CUPA minutes are posted to the CSC website. The exam lead will send one reminder email to candidates who have not turned in their proof of education requirement (commander exam).

The CSC shared that both exams will have application filing periods of approximately 2 weeks in length.

Information Sessions

For the 2024 exam administrations video based information sessions will be produced and available on the CSC webpages for each of the exams. The video format allows candidates to access and view the information at their leisure and as often as they like. This format also provides all candidates the same information. The Police Lieutenant video is scheduled to be available by August 1, 2024 and the Police Commander video by April 25, 2024.

Questions and Answers (Q & A) Document

There will be a Q & A resource posted on the CSC website for each exam once the CSC receives questions. The purpose of this document is to provide a consistent method to share answers to questions that have not already been answered by other materials available to candidates. If a question is asked that is already answered in a posted document, the candidate will be directed to that document, these questions will not be added to the Q & A. If a question is asked that is not already answered in any posted documents, the answer will be answered as soon as it is added to the Q & A. This ensures candidates have access to all the questions and answers consistently.

Reading List

The CSC presented the proposed Police Commander (attached document 3a) and the Police Lieutenant (attached document 3b) Reading Lists. The information regarding the reading list is confidential until posted to the CSC's website. Information discussed regarding the reading list:

- The Reading List cutoff date for Police Commander is July 1, 2023 and for Police Lieutenant is October 1, 2023. Source updates after these dates will not be included in materials for the exam.
- The 2021, 2022, and 2023 In-Service Training and Legal Updates for officers will be used for these examination processes.
- Outside sources may be added as reading list addendums at the time of application filing for each rank.

There were no objections to the Police Lieutenant or Police Commander Reading Lists.

Exam Phases

The Police Commander exam will consist of two phases, an Oral Board and a Written Work Sample. Each phase will be weighted 50% (attached document 4a). The Police Lieutenant exam will consist of 4 phases; open-book multiple-choice, closed-book multiple-choice, written work sample and an oral board. Each phase will be weighted 25% (attached document 4b).

Subject Matter Experts

Subject matter expert (SME) needs per exam were shared (attached document 5a and 5b). CSC confirmed that the CSC will request SMEs and will reach out through the Division liaison as needed to request assistance with the Police Lieutenant and Commander Exams. When SMEs express interested in assisting they will contact Chelsea Whims to be placed on a list of potential SMEs. The Division and FOP liaisons will inform the CSC of individuals who should not be used as SMEs. Individuals who may be excluded may have recent discipline, are under investigation, or plan to retire in the very near future. The FOP stated that they would like to be made aware of any SME placed on a "do not use" list and the reason why. It was also noted that for exam security no one SME would work on the exam in its entirety. The need for Police

Commander SMEs is coming up quickly and the lead analyst will begin making requests for SMEs directly after this meeting.

Exam Phase Details

For the Police Commander exam the following was noted:

- The WWS will be conducted on laptops or computers and depending on the number of candidates will either be conducted at 1111 East Broad Street or at 77 N. Front Street.
- The OB will be at 1111 East Broad Street all in one day with a sequestering of candidates.
- All candidates that complete both phases of the exam will be on the eligible list.

 Placement will be based on scoring and the addition of seniority points.

For the Police Lieutenant exam the following was noted:

- Both the open-book and the closed-book multiple-choice phases of the exam will be held on one day and administered at 1111 East Broad Street.
- The WWS will either be at 1111 East Broad Street or at 77 North Front Street dependent on the number of candidates.
- The OB will be at 1111 East Broad Street with a sequestering of candidates.

Results Release Procedures

Attached document 6a and 6b describes the results release procedure for Police Commander and Police Lieutenant. CSC confirmed that results will be sent to the following:

- The Department of Public Safety Doug Sarff
- The Union Brian Steel and the FOP President
- The Division CSC liaison Police Deputy Chief Konves

The remaining results release procedures were reviewed. An emphasis was made that the tentative results period is the time for results to be reviewed by candidates, the FOP exam consultant, and for seniority points to be reviewed by the union. Any questions or discrepancies should be reported to the CSC as soon as possible so that any issues can be resolved before the eligible list being finalized.

Test Accommodations

For candidates requesting military and ADA accommodations, testing accommodations will be handled on case-by-case basis and candidates must take the exam on the same day as all other candidates. Accommodation requests are encouraged to be submitted early as timeliness is a factor in being able to grant the accommodation. Approved military accommodations for those who are offsite will require proctoring where the candidate is stationed. Accommodations for appeals and clerical reviews (lieutenant exam only) will only be considered for required military or required work related events that occur on all available appeal or clerical review days. Accommodations for appeals and clerical reviews may only be granted in cases that will not delay exam results/scoring. All accommodations are handled on a case-by-case basis.

Additional Concerns

 The CSC revisited a topic suggested by the FOP consultant that was discusses at the most recent CUPA meeting. The CSC asked if any progress had been made on the

- division developing training or hiring a consultant to provide training for exam candidates. No update by representatives was given.
- The CSC confirmed receipt of the FOP test consultant's list of concerns and requests for the upcoming exams.
- The FOP representative noted that there is an arbitration in process that could potentially cause 8-10 Police Lieutenant candidates and 1 Police Commander candidate from a previous list to be reconsidered/hired. This could potentially fill positions that could have been available for those placed on the 2024 eligible lists. The FOP plans to advise their membership accordingly.

2024 Police Commander Results Release Procedures Police Commander

- 1. On Monday, June 10, 2024 the Civil Service Commission will:
 - a) Issue to the Fraternal Order of Police Capital City Lodge No.9's (henceforth referred to as "the Lodge") testing consultant, the person identification numbers, raw scores, z-scores, scores by dimensions, subtotal scores, seniority points, final scores, and resultant ranks of the 2024 Police Commander Examination;
 - b) Issue to the Lodge, by email, a list of all candidate names and seniority points;
 - c) E-mail the tentative results notice to the candidates indicating their raw scores, scores by dimension, the high, low, and mean scores for each phase, the candidate's seniority points, and the information needed to schedule a review of their video responses and copies of their scan sheets.
- 2. On Monday, June 24, 2024 (represents one (1) business day prior to the effective date of the list):
 - a) A final results notice will be sent via email to candidates indicating their final score and ranking on the eligible list;
 - b) A copy of the final eligible list will be emailed to the Department of Public Safety, the Division of Police CSC Liaison, and the Lodge at approximately 10:00 a.m.
- 3. The eligible list will be effective at 12:00 a.m., Tuesday, June 25, 2024.
- 4. Should the Lodge not retain a testing expert for this exam; the Commission will proceed with this procedure as noted with the exception of issuing the information to the consultant as stated in Step 1, a).

2024 Police Lieutenant Results Release Procedures Police Lieutenant

- On Thursday, October 31, 2024 (represents 10 working days prior to the expiration of the current Police Lieutenant eligible list), the Civil Service Commission will:
 - a) Issue to the Fraternal Order of Police Capital City Lodge No.9's (henceforth referred to as "the Lodge") testing consultant, the person identification numbers, raw scores, z-scores, scores by dimensions, subtotal scores, seniority points, final scores, and resultant ranks of the 2024 Police Lieutenant Examination:
 - b) Issue to the Lodge, by email, a list of all candidate names and seniority points;
 - c) Email the tentative results notice to the candidates indicating their raw scores, scores by dimension, the high, low, and mean scores for each phase, the candidate's seniority points, and the information needed to schedule a review of their own video responses and copies of their own scan sheets.
- 2. On Thursday, November 14, 2024 (represents one (1) business day prior to the effective date of the list):
 - a) A final results notice will be sent via email to candidates indicating their final score and ranking on the eligible list;
 - b) A copy of the final eligible list will be emailed to the Department of Public Safety, the Division of Police CSC Liaison, and the Lodge at approximately 10:00 a.m.
- 3. The eligible list will be effective at 12:00 a.m., Friday, November 15, 2024.
- 4. Should the Lodge not retain a testing expert for this exam; the Commission will proceed with this procedure as noted with the exception of issuing the information to the consultant as stated in Step 1, a).
