**Incident Summary:** On November 26, 2023 at approximately 2:40 PM the victim was inside her home and heard a gunshot outside of her home. As she went outside to check on her dog she observed the suspect punching her dog while holding a firearm. When victim questioned suspect if he had shot at her dog, suspect replied "Yes, next time I'll shoot at you bitch" as he raised and pointed a handgun directly at her.

The black male suspect was described as approximately 25-30 years of age, 5'07" to 5'09" tall and 150-180 pounds with a mark beneath his left eye and visible tattoos on backside of his left and right hands. Suspect was wearing a blue "doo rag" with black hooded jacket, black pants and shoes (see attached photos).
