Incident Summary: On December 6<sup>th</sup>, 2023, at approximately 7:00 pm, three male blacks engaged in an altercation with patrons inside of the location. As a result, the suspects were asked to leave by security. Once outside, a physical altercation ensued between the three males and the victim. Subsequently, the victim was transported to a local hospital in critical conditon. The suspects fled the scene in a red vehicle.

**Charges: Murder** 

The previously unnamed victim was Donald Smith Jr., 53. On December 18, 2023, Smith succumbed to his injuries and was pronounced deceased. Meanwhile, this investigation was transferred from Robbery to Homicide.

On December 20, 2023, Homicide Detectives filed Murder charges against Dionta Hughes, 18, Jamarion Evans-Bennett, 19, and Jayden Agee, 17, for causing Smith's death. Later that same day Hughes, Evans-Bennett and Agee were arrested by Columbus Police Officers and are currently incarcerated.
