Incident Summary: UPDATE: The listed suspects have all been charged with Murder in the death of Mr. Joe-Summerall.

Suspect #3- Marshawn E. Hudson M/B 14, Columbus, Ohio-Charged with Murder (in custody)

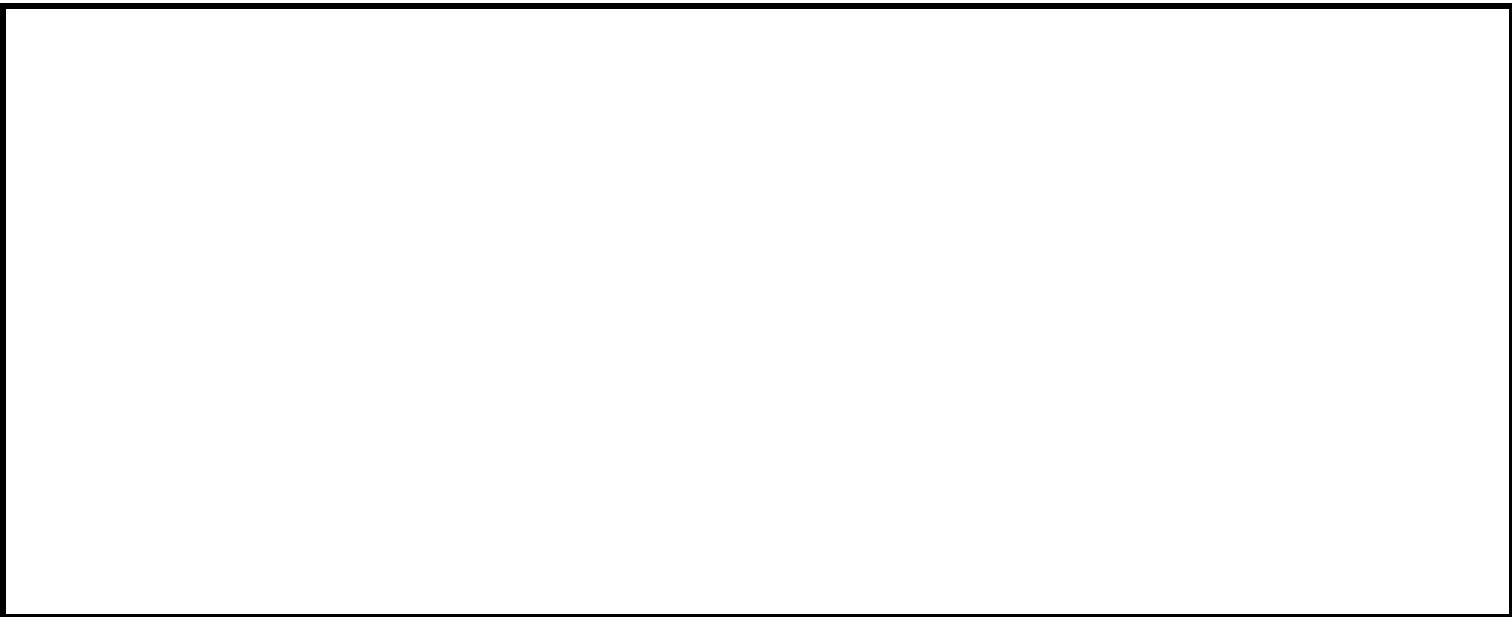
Suspect #4- Zion D. Barnett M/B 14, Columbus, Ohio-Charged with Murder (in custody)

Each suspect is in custody EXCEPT:
Suspect #5- Dreyton N. Lane M/B 16, 3033 Watermill Apt. 201, Columbus, OH 43207-Charged with Murder (NOT in custody). He is armed and dangerous. If located, do not approach him, call 911 immediately.

On Saturday, August 26th, 2023, at 2:23PM, Columbus Police Officers were called to a business located in the 1500 block of Schrock Rd. on a report of a shooting. On arrival, officers found Nathaniel Joe-Summerall, 19, suffering from an apparent gunshot wound. CFD Engine 6 responded and pronounced Joe-Summerall deceased at scene at 2:32PM. A short time thereafter, a second adult who had also been shot, arrived at Riverside Hospital by private conveyance.

Shortly before the shooting Joe-Summerall, the second adult, and several males gathered in the parking lot of the business in what appeared to be a planned meeting. Shortly after they met up, a fight broke out. During the fight there was an exchange of gunfire. Joe-Summerall and the second adult were both wounded during this exchange.
