Incident Summary: ***Update 8.29.2023: Anthony Bogins was arrested on August 29, 2023, on warrants for Weapons Under Disability and Tampering with Evidence. The Investigation continues.***

*** UPDATE: The victims have been identified as NICHOLAS EALY, M/B/41, and ALBERTO DELEON, M/B/69. Next of kin notification has been made. ***

On August 6, 2023, at 12:35 PM, Columbus Police officers were dispatched to the 1400 block of E. Mound St. on a reported shooting. Upon arrival, the officers located a victim, ADULT #1, suffering from a gunshot wound. Columbus Fire medics arrived and transported ADULT #1 to a local hospital, where ADULT #1 was pronounced deceased at 1:01 PM. A separate victim, ADULT #2, was self-transported to a local hospital suffering from gunshot wounds from this same incident. ADULT #2 was pronounced deceased at 1:14 PM.

The victims have not been positively identified. The preliminary investigation revealed an argument took place involving the victims prior to the shooting. The investigation continues.
