UPDATE #1 - On January 25, 2023, the Franklin County Coroner's office positively identified the victim in this Homicide as 44-year-old Hajid Jordan. Mr. Jordan was a reported Missing Person from Maryland. Homicide detectives continue to investigate.

UPDATE #2: - Detectives have filed warrants charging 44-year-old William Marcole Robertson and 24-year-old Tajuan Antonio Smith with Murder for causing Jordan's death. Robertson has been arrested and is currently incarcerated in the Franklin County Jail. Smith is still at large. Anyone who knows Smith's whereabouts is asked to contact police.
