**Incident Summary: \*\*\*Update: October 6, 2023, the Grand Jury was presented with additional information on this case. They indicted Raymor A Dumas for Tampering with Evidence and Obstructing Justice. A warrant has been issued for his arrest. October 4, 2023, patrol officers, working 9pct, arrested Michael Bowles without incident. He was processed and slated at the Franklin County Jail.

On September 21, 2023, a missing person's report was filed. The Missing Persons Unit's investigation indicated this incident may involve foul play. On September 24, 2023, the Homicide Unit was asked to assist with the investigation. Evidence collected during the investigation implicated Michael T. Bowles and Russell Madison-Hargrove as being involved in a homicide. Several other individuals have been charged as a result of this investigation.
