Incident Summary: ****Update: On September 21, 2023, both Levander Davis and De'Andre Davis were arrested by task force officers in the 3000 block of E 6th Ave. They are currently incarcerated in the Franklin County Jail.****

****Update: July 11, 2023, the suspects in this homicide have been identified as Levander Davis M/B/25 and De'Andre Davis M/B/25. Warrants for murder have been filed for their arrest. Anyone with information on their whereabouts should contact the Columbus Division of Police.****

On July 5, 2023, at approximately 12:14am, officers were dispatched to the 700 block of Kerr St on the report of shots fired. Officers arrived at the scene and found Victim #1 suffering from multiple gunshot wounds. Columbus Fire Medic #1 personnel arrived and pronounced the victim deceased at 12:24 am. Victim #2 was transported to a local hospital by Medic #1 and is listed in stable condition. Witnesses stated there was a verbal dispute that escalated into the shots being fired, this investigation is ongoing.
