Incident Summary: On Wednesday, September 6th, 2023, in response to a known drug house affecting the Reeb-Hosack, Hungarian, Vasssor, and Merion neighborhoods, an investigation led to several narcotics houses being connected on the South/East Side of Columbus. Through the collaboration of the Zone 5 South Central Safe Streets team, Zone 5 & Zone 2 CPD Patrol Officers, the Organized Crime Bureau: (Narcotics, Criminal Intelligence Unit, INTAC), Fairfield County SWAT, and Columbus city code enforcement, search warrants were executed for multiple locations.

The result of this collaborative operation resulted in the following:

- A problem residence in the 200 BLK of Innis Ave boarded up and placarded.
- 2 Vehicles Impounded.
- 1 Stolen Rifle Recovered.
- 2 Rifles, 1 AR-Shotgun, and 5 Handguns recovered.
- Narcotics Kilogram press and drug manufacturing equipment recovered.
- Approximately 550+ grams of Suspected Fentanyl recovered.
- Approximately 1300+ grams of Marijuana recovered.
- Approximately \$8500 Cash.
- 10 Search Warrants Served.
- "Glock Switch" automatic conversion device.
