Meeting Goals

- Listen...Listen...Listen
- Gather information
 - High demand parking areas
 - Peak parking demand times of day and days of week
 - Appropriate boundaries for the study
 - Mobility requests
- Facilitate one-on-one/small group discussions
- Answer general mobility & parking questions



Strategic Parking Plan (2019)

- Plan outlined existing conditions and made parking management recommendations for:
 - University District
 - Franklinton
 - Downtown
 - South of Downtown
 Neighborhoods
- Not a one size fits all approach, each area is unique

- Data is outdated but serves as a good baseline
- Tackling key recommendations in May 2023:
 - Virtual permitting
 - LPR enforcement





Virtual Permitting

- Scheduled to start June 1, 2023
- No more stickers and hangtags
- Ability to apply for, renew and manage your permits online
 - Manage your resident permit and guest permit through your customer portal
 - Update license plate information in real time as often as you like
 - Have the ability to store "favorite" plates in your portal
 - Only one license plate number can be active on each permit
- No longer submit your vehicle registration
 - Required to submit valid gov't issues ID/driver's licenses and proof of residency
- Enforcement through license plate recognition
- May still apply in-person at Parking Services
- More information coming to our website and in the mail



What is a Parking Study?

• Data Collection

- Parking counts at different times of day throughout the week
- Parking duration how long are vehicles parked
- Identifying objective on-street demand
- Review parking signage
- Curb lane programs (permits, loading, valet)
- Understanding perceptions
 - Residents
 - Businesses
 - Visitors
- Not recommending any solutions





What We've Heard

- Business driven parking demand
- People who work downtown and park in the neighborhood
- Development creating excess demand on parking
- Visitors having inadequate parking options near their destinations and park on residential streets instead
- 3rd Street safety concerns
- Inconsistent or confusing signage including permit zones and current restrictions
- Loading and valet zones
- Desire for more bike facilities, alternative transportation options, and public transit connections

Summer 2023: Form Stakeholder Groups; Collect Data

Fall/Winter 2023: Analyze Data; Public Meeting(s) to Present Parking Data

Winter 2023/Spring 2024: Stakeholder Working Group Meetings











