# Limited Environmental Review and Finding of No Significant Impact

### City of Columbus – Franklin County Dublin Road 30-Inch Water Main Loan number: FS390274-0347

The attached Limited Environmental Review (LER) is for a water main extension project in Columbus which the Ohio Environmental Protection Agency intends to finance through its Water Supply Revolving Loan Account (WSRLA) below-market interest rate revolving loan program. The LER describes the project, its costs, and expected environmental benefits. Making available this LER fulfills Ohio EPA's environmental review and public notice requirements for this loan program.

Ohio EPA analyzes environmental effects of proposed projects as part of its WSRLA program review and approval process. We have concluded that the proposed project should not result in significant adverse environmental impacts. This project's relatively narrow scope and lack of environmental impacts qualifies it for the LER rather than a more comprehensive Environmental Assessment. Upon issuance of this Finding of No Significant Impact (FNSI) determination, award of funds may proceed without further environmental review or public comment unless new information shows that environmental conditions of the proposed project have changed significantly.

#### LIMITED ENVIRONMENTAL REVIEW

#### **Project Identification**

Project: Dublin Road 30-Inch Water Main

Applicant: City of Columbus 910 Dublin Road Columbus, Ohio 43215

### Project Summary

The City of Columbus in Franklin County has requested funding from the Ohio Water Supply Revolving Loan Account (WSRLA) for construction of a 30-inch water main extension on Dublin Road extending to the Blazer Water Storage Tank. The project is necessary in order to improve water transmission and turnover in the Blazer Tank in the northwest part of the distribution system.

#### **History & Existing Conditions**

Columbus operates an extensive water treatment and distribution system that serves the city and most of Franklin County, delivering 50 billion gallons of water per year to its service area. Raw water is sourced from the Big Walnut Creek, treated at Hap Cremean Water Treatment Plant, and transported through existing water lines to provide water service to the area near Dublin Road and Hayden Run Road. This area is currently experiencing increasing water demands as population and industry continues to grow.

#### **Project Description**

This project will install a new water transmission main from the intersection of Shire Creek Court and Dublin Road to the Blazer Parkway elevated storage tank. The goal of this project is to meet increasing water demands in the northwest part of Columbus Division of Water's service area.

The project will include approximately 12,000 linear feet of new 30-inch diameter water line. Along with the installation of the new water main, the project will also include new fire hydrant installations. The new ductile iron pipe in the replacement water lines will have an estimated service life of 100 years.

The construction footprint for these projects will remain within the previously disturbed rights-ofway alongside and within the roadway, thereby minimizing effects on environmental resources. The contractor is responsible for best management practices to control dust, erosion, and sedimentation, and maintain local traffic during construction.

### **Implementation**

# Project Costs

Columbus plans to borrow \$8,409,775 from the WSRLA. During the 20-year loan period, Columbus will save approximately \$1,319,081 by using WSRLA dollars at the standard rate of 2.93%, compared to the market rate of 4.18%. Interestrates are set monthly and may change for the requested January loan award.

### Local Economy

The current Columbus residential water bill is approximately \$544/year. Projected residential water bills with the implementation of this and other associated projects are expected to increase to approximately \$610/year, or 1.1% of median household income (MHI) of Columbus, which is \$54,902.

By using WSRLA financing for this project, Columbus has minimized the economic impact on customers.

### Project Schedule

The anticipated loan award will occur in January 2023. Construction is expected to begin following loan award and be completed by October 2023.

### Public Participation

Public notices were posted on the City of Columbus's Public Utilities webpage which detailed the proposed water line construction and contact information is provided for any public questions or concerns. Notices are also to be distributed to affected residents prior to construction.

# <u>Conclusion</u>

The proposed project meets the criteria for a Limited Environmental Review (LER); namely, an action which involves improvements to existing water distribution infrastructure. Furthermore, the projects meet the other qualifying criteria for an LER; specifically, the proposed project:

- Will have no significant environmental effect, will have no effect on high-value environmental resources, and will not require extensive specific impact mitigation. The project includes construction of new water lines within the previously disturbed rights-of-way alongside or within the roadway; therefore, areas lacking important environmental features. No stream crossings or in-wetland work is scheduled to occur, and there will be no construction within prime farmland or within the floodplain. If necessary, tree clearing is to occur within seasonal clearing dates to protect endangered bat species located in the area. The contractor is responsible for dust control, sedimentation, and erosion control, and maintenance of traffic during construction.
- Is cost effective and not controversial.

The proposed project is cost effective, as the overall costs and benefits of the construction of a new water main outweigh taking no action, which would leave current water distribution infrastructure vulnerable to increased water demands, leading to potential maintenance costs and insufficient water supply. DEFA is unaware of any specific opposition to or controversy about this project that will improve the safety and efficiency of a continuous supply of potable water to customers.

• Does not create a new or relocate an existing discharge to surface or ground waters, does not create a new source of water withdrawals from either surface or ground waters, or significantly increase the amount of water withdrawn from an existing water source, or substantially increase the volume of discharge or loading of pollutants from an existing source or from new facilities to receiving waters.

This project involves the construction of an additional water line which services the area. It does not otherwise alter Columbus's public water system (withdrawal, treatment, distribution, or usage of potable water).

Based upon the available planning information for this project and the materials presented within this LER, Ohio EPA concludes that the proposed project will not result in any significant adverse impacts to any environmental features. The project is expected to have no significant short-term or long-term adverse impacts on the quality of the human environment or on sensitive resources such as surface waters, coastal zones, riparian areas, floodplains, wetlands, state-designated scenic or recreational rivers, prime or unique agricultural lands, aquifer recharge zones, archaeologically or historically significant sites, or threatened or endangered species.


This project will help to ensure the safety and efficiency of water distributed to the Columbus area.
