П. **Material**

GENERAL

Crossarms conforming to the Division of Power crossarm specification and approved Α. shop drawings shall be installed as indicated on the project drawings.

PRODUCT REQUIREMENTS

- All materials shall be in strict compliance with the following applicable standards. Α.
 - ANSI 05.1 Specification and dimensions for wood pole latest revision. 1.
 - AWPA C-1-89 Standard for preservative treatment by pressure process all 2. timber products, latest revision.
 - AWPA P-8-89 Standards for oil-bourne preservatives. 3.
 - AWPA-C-9-87 Standards for oil-bourne preservatives. 4.
 - REA 1728H-701 Standard for preservative treatment by pressure process all 5. timber products, latest revision.
- Species: All crossarms shall be manufactured from Douglas Fir timber, in Β. accordance with REA specifications 1728H-701.
- C. Preservative Treatment: All crossarms shall be cured and have all manufacturing processes completed prior to treatment. Crossarms shall be cured in accordance

with the latest revision of the American Wood Preservers Association (AWPA) guidelines as published in the latest revision of their Book of Standards. Treatment shall be accomplished using a solution of pentachlorophenal, with methods, preparation and solvents as directed in the AWPA Book of Standards.

- Retention shall be as follows: Ε.

SPECIES ASSAY ZONE (ins.) Douglas Fir 0.25-1.00

Treated crossarms shall be tested for penetration and retention using AWPA Standards. Treatment reports shall be approved by the inspector and shall be furnished with the crossarm shipment.

Crossarms shall be incised to a depth of one-eight (1/8") on all four (4) sides before treatment. Holes shall be drilled before treatment.

WARRANTY

Drilling: Dimensions and drilling shall be strictly in accordance with Division of Power

MINIMUM RETENTION (pcfAs Pentachloropheanal) .40

Crossarms shall be warranted for a minimum of one and one half (1 1/2) years from date of delivery and one (1) year from date of installation. Should any problems occur during the warranty period, the contractor shall, upon written notification and entirely at their expense, correct the problem by replacing the defective crossarms

Single crossarms are used on straight lines where no excessive strain needs to be provided for. In general, single crossarms shall be mounted on alternative faces of the poles installed in a line (face to face and back to back). When a single crossarm is installed on the first pole from a corner or deadend it shall be mounted on the side of the pole away from the crossing or deadend. See TDMIS-11, sheet 7 & 10.

Double crossarms shall be used at line terminals, corners, angles, or at other points where there is an excessive strain. Where lines cross railroads, water or freeways,

double arms shall be used, as more than ordinary safety is required at such locations. See TDMIS-11, sheet 8 & 11.

- C. Triple crossarms shall be used where spans are long, requiring the extra support of three crossarms. See TDMIS-11, sheet 9 & 12.
- D. Alley arms shall be used in alleys or other locations where it is necessary to clear buildings, etc. See TDMIS-11, sheet 5 & 6.

IV. <u>Method of measurement</u>

Shall be measured as completed units per each configuration detail including all materials, labor, transportation. Shall be measured as complete units for each length of crossarm with framing and will include brackets, bolts, braces, etc.





DETAIL 1 **CROSSARM DRILLING GUIDE - DISTRIBUTION**
