# 24" Spacer Cable Tangent Bracket Tangent 5° or Less

### I. <u>Quantity</u>

The base bid shall include the indicated number of 24" spacer cable tangent brackets furnished and installed as hereinafter specified.

### II. <u>Material</u>

- A. 24" spacer cable tangent bracket- Supplied with messenger clamp for ½ inch to 9/16 inch messenger. Hendrix BM-24 or approved equal.
- B. Ground Wire The ground wire shall be #6 solid soft drawn bare copper.
- C. Connectors copper compression type.
- D. All steel hardware to be hot dipped galvanized.

#### III. Installation

- A. The installation shall be as shown on drawing TDMIS-301.
- B. The 24" bracket shall be used on tangent poles and line angles up to and including five (5) degrees, to attach the messenger wire to the pole. Cable spacers (see TDMIS-310) are then used to support the spacer cable from the messenger.
- C. The 24" bracket can be used in lieu of a 14" bracket where a longer bracket would reduce a line angle or where the conductor needs to be farther from the pole.

#### IV. Method of measurement


