

Expanded Land Stewardship Program Now Available to Adjacent Property Owners

As the Department of Public Utilities continues to work with its consultant on watershed master planning, we are pleased to announce that additional options will be available through the Land Stewardship Program starting this spring. The department remains committed to protecting the quality of the city's drinking water reservoirs and the riparian buffers located on them. These new options described below will be available on city-owned reservoir land where the creation of such would not adversely affect water quality or sensitive riparian habitat, at the adjacent property owner's expense.

- Access paths (without the requirement of a boat dock or stake): paths up to five feet in width may be
 approved using the following materials, listed from most preferred to least: mown grass, soil, natural and
 undyed mulch, washed river gravel, and stepping stones. Proper installation is required and monitoring for
 soil erosion applies. The contiguous land owner will be responsible for ensuring the path is safely passable,
 maintained in good condition and to the original specification.
- View corridors: creation of one view corridor per property will be possible using prescribed methods (up to
 a 50' width maximum at any point). Methods include: removal of noxious weeds and invasive species (as
 defined by ODNR), and/or planting low-growing species from an approved native plant list, pruning native
 volunteer saplings to reduce multiple trunks or leaders, and/or replacing non-native or tall native shrubs with
 lower growing native shrubs, and crown raising by pruning of trees. Annual maintenance of the view corridor
 may be requested, and all trimming must be authorized in advance and performed by an approved International Society of Arboriculture certified arborist.
- Noxious weed and invasive species removal: approved professionals contracted by the contiguous property owner or by the City of Columbus can address invasive growth through the use of methods aimed at removing the invasive plants and preventing re-establishment. Pesticide use and any associated tree removal will require appropriate licenses, as well as demonstrated knowledge of plant identification.

Not all properties will be eligible for these options. For example, paths may not cross a wetland or nature preserve, and the creation of a view corridor may not harm a wetland, or sensitive plant species. Path alignments will be designed to minimize environmental impact and overlap current paths when applicable. Only diseased, hazardous or sapling trees can be removed to establish a path. Slopes, mature trees, and erodible soils are also considerations. Additionally, the following properties will not be eligible:

- Properties that have an existing encroachment on city-owned property; encroachments must be resolved before an LSA can be obtained
- Properties that are more than 250 feet from the reservoir shoreline
- Properties adjacent to a nature preserve

To discuss or apply for the new options, please contact the Watershed Management Office at (614) 645-1721 or email watershed@columbus.gov. Those with an existing land stewardship agreement can apply for a modification to their agreement, and those without an existing agreement can apply for a new one. Options and details will be discussed through that process.

Invasive Species Pilot Project Update

We have completed approximately 60 acres of invasive species removal on city-owned land around the Griggs, O'Shaughnessy and Hoover Reservoirs. Each site will receive a second treatment this spring to minimize regrowth, and removal on some city-owned properties will continue this year through contracted services set up last year. Reservoir Area Construction Season Information

2015 Boating Season Information

Public marina season begins on May 1 at Griggs, O'Shaughnessy, and Hoover Reservoirs. Docks are available at all three reservoirs.

Griggs and O'Shaughnessy marina docks will be available on a first come, first served basis beginning April 20.

Hoover marina docks will be awarded in a lottery on April 23. The lottery will start promptly at 9:00 AM in the Jerry Hammond Center, 1111 East Broad Street, Columbus, OH, 43205.

If you wish to rent a dock, please bring a valid Ohio boat registration and payment. The dock and the boat must be registered in the same name. A bill of sale will initially be accepted if a boat is not yet registered.
