## **Eligibility Requirements**

To be eligible for a senior discount on a City of Columbus water bill, the customer must meet the requirements below. Those approved will not be charged the daily water service fees.

- Be 60 years of age or older.
- Have an active City of Columbus water account in your name (or your spouse's name).
- Live in a single family home with one water meter.
- Household income must be less than 150% of the current U.S.
   Bureau of Census federal poverty level. Total household income for last year must meet the guidelines on the chart below.

Please note: do not include disability payments paid by the V.A. or any branch of the U.S. Armed Forces when calculating total income.

## Other Information

If a customer becomes ineligible for the discount because their household income no longer meets the requirements, Customer Service must be notified as soon as possible, but no later than 30 days after the ineligibility.

Be aware that falsifying information or failing to notify a change in eligibility status may lead to:

- Termination of water service
- Recovery of past discounts
- Civil and/or criminal sanctions

If you qualify for this senior discount, you will also receive a 20% low income water and sewer discount on consumption charges. If you are over 60 and meet the income requirements, you do not need to complete both applications; just send in the senior application for consideration on both programs.
